

GlobalFoundries Inc. (GFS): Key takeaways from 2026 Investor Day

Key stock takeaways: GlobalFoundries hosted its Investor Day on May 7. We expect the stock to trade higher on the prospects for improving revenue growth and profitability metrics, along with an upgraded long-term financial model. We walked away from the event with increased confidence that GlobalFoundries should be able to improve its revenue performance as fast-growing idiosyncratic opportunities (silicon photonics, automotive, and IoT) become a more meaningful part of the company's revenue mix. In addition, the changes to the composition of GF's product portfolio (IP, value-added services) as well as improved utilization should help drive meaningful improvement in gross margins and overall earnings power over time. We are Neutral on the stock given near-term headwinds posed by conventional smartphone and consumer markets, but could become more constructive as these headwinds subside and the company's idiosyncratic drivers become more apparent.

Our key takeaways are as follows:

- **Strategy:** GlobalFoundries is strategically positioning itself at the center of high-growth datacenter and physical AI markets, shifting away from its traditional smartphone market. Management reiterated that AI-driven shifts from copper to optical and from legacy to high-voltage datacenters create a step function change in compute utilization and energy efficiency, playing directly into GF's SiPh, SiGe, BiCMOS and GaN capabilities and turnkey manufacturing in the US, Germany and Singapore.
- **Financial outlook:** Management outlined a long-term framework calling for a 10%–12% through-cycle revenue growth, with SMD declining to ~25% of manufacturing services revenue by 2030 (from ~45% in 2025). Gross margins are targeted at ~40% exiting 2028 and ~45% long term, with operating margins of ~25% and ~35%, respectively, driven by favorable mix, higher utilization, value-added services, and manufacturing optimization. The model implies EPS of ~\$4.00 exiting 2028 and ~\$6.00 long term, net CapEx of ~20% of revenue, and FCF margins above 10%. GF also announced its first quarterly dividend of \$0.12/share and plans to return up to 50% of TTM FCF via dividends and buybacks.
- **End markets:** In its revenue forecast, GF expects to outgrow most key markets such as CID (over 30% CAGR by 2030), Automotive (low-double-digits %) and IoT (mid-teens %), while SMD remains largely flat. CID (optical networking, SiGe,

NSX), Automotive (ADAS, radar, zonal architectures), and IoT (eNVM-enabled, always-on edge AI) were all highlighted as strong momentum areas.

- **Technology:** Management framed GF's next growth phase as an evolution from a pure-play foundry to a full-stack technology partner spanning optical networking, advanced packaging, and custom silicon/IP via MIPS. In datacenters, GF is leveraging its early SiPh investments to support 1.6T+ across pluggables and CPO, driven by SCALE (its OCI-compliant CPO platform) with SiPh revenue expected to exceed \$400mn in 2026 and reach ~\$2bn by 2030 as near- and co-packaged optics ramp in 2028. Datacenter power solutions (GaN and BCD) are expected to contribute an incremental ~\$1bn by 2030, while GF sees further upside from IP licensing, software and custom silicon (collectively targeting a ~\$1bn revenue run rate by 2030).

Price Target Methodology and Risks

Price target. We maintain our price target of \$70, which is based on a 25X P/E multiple applied to our normalized EPS of \$2.80. Key upside/downside risks: (1) stronger momentum in the smartphone market; (2) additional US manufacturing subsidies; (3) pricing compresses in trailing-edge nodes; (4) company's LTAs downtick.

We are Neutral rated on GFS. We believe the datacenter and automotive segments will serve as an idiosyncratic growth engine for GlobalFoundries as new design wins continue to ramp and customers look to lock in US-based manufacturing capacity over long design cycles. However, we expect pricing and inventory dynamics to remain headwinds in Smart Mobile Devices and Consumer/IoT in the near term.

GS Factor Profile

The Goldman Sachs Factor Profile provides investment context for a stock by comparing key attributes to the market (i.e. our universe of rated stocks) and its sector peers. The four key attributes depicted are: Growth, Financial Returns, Multiple (e.g. valuation) and Integrated (a composite of Growth, Financial Returns and Multiple). Growth, Financial Returns and Multiple are calculated by using normalized ranks for specific metrics for each stock. The normalized ranks for the metrics are then averaged and converted into percentiles for the relevant attribute. The precise calculation of each metric may vary depending on the fiscal year, industry and region, but the standard approach is as follows:

Growth is based on a stock's forward-looking sales growth, EBITDA growth and EPS growth (for financial stocks, only EPS and sales growth), with a higher percentile indicating a higher growth company. **Financial Returns** is based on a stock's forward-looking ROE, ROCE and CROCI (for financial stocks, only ROE), with a higher percentile indicating a company with higher financial returns. **Multiple** is based on a stock's forward-looking P/E, P/B, price/dividend (P/D), EV/EBITDA, EV/FCF and EV/Debt Adjusted Cash Flow (DACF) (for financial stocks, only P/E, P/B and P/D), with a higher percentile indicating a stock trading at a higher multiple. The **Integrated** percentile is calculated as the average of the Growth percentile, Financial Returns percentile and (100% - Multiple percentile).

Financial Returns and Multiple use the Goldman Sachs analyst forecasts at the fiscal year-end at least three quarters in the future. Growth uses inputs for the fiscal year at least seven quarters in the future compared with the year at least three quarters in the future (on a per-share basis for all metrics).

M&A Rank

Across our global coverage, we examine stocks using an M&A framework, considering both qualitative factors and quantitative factors (which may vary across sectors and regions) to incorporate the potential that certain companies could be acquired. We then assign a M&A rank as a means of scoring companies under our rated coverage from 1 to 3, with 1 representing high (30%-50%) probability of the company becoming an acquisition target, 2 representing medium (15%-30%) probability and 3 representing low (0%-15%) probability. For companies ranked 1 or 2, in line with our standard departmental guidelines we incorporate an M&A component into our target price. M&A rank of 3 is considered immaterial and therefore does not factor into our price target, and may or may not be discussed in research.

Quantum

Quantum is Goldman Sachs' proprietary database providing access to detailed financial statement histories, forecasts and ratios. It can be used for in-depth analysis of a single company, or to make comparisons between companies in different sectors and markets.

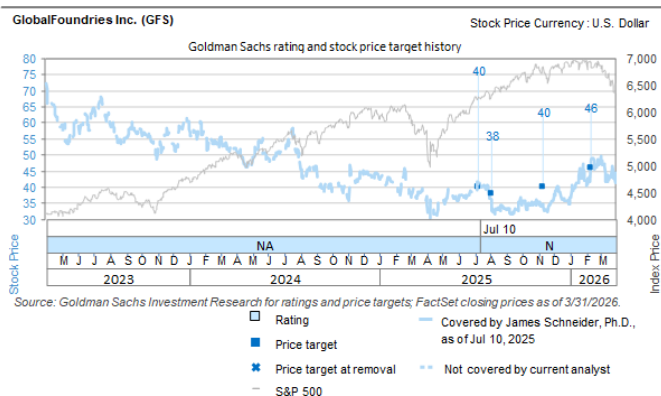
